

Privacy Policy



MND Beast Challenge and its related entities respects and upholds your rights under the Australian Privacy Principles contained in the Privacy Act 1988 (Cth) and the Information Privacy Principles contained in the Privacy Act 2020 (Privacy Act).

This Privacy Policy for MND Beast Challenge lets you know:

- what personal information of yours we hold;
- what we do with it;
- who we will disclose it to; and
- how you can access the personal information we hold about you.

HOW DOES MND BEAST CHALLENGE COLLECT AND HOLD YOUR PERSONAL INFORMATION?

Where possible, MND Beast Challenge will generally collect your personal information directly from you. MND Beast Challenge may also collect your personal information from third parties who provide your personal information to us to allow us to contact you. We may also collect personal information from our website or social media platforms that we operate or may establish.

WHAT PERSONAL INFORMATION ABOUT YOU DOES MND BEAST CHALLENGE COLLECT AND HOLD?

The types of personal information that MND Beast Challenge collects from you will be directly related to the specific purpose for which it has been collected. How much personal information that you choose to disclose to us is completely up to you. The only way we know something about you personally is if you provide it to us. However, failure to provide certain information may result in MND Beast Challenge being unable to provide you with the relevant service.

The information MND Beast Challenge collects will include:

- If you request information from us directly (e.g. via our website) we may collect information from you such as your name, email address and phone number(s).
- If you make an enquiry, provide feedback or make a complaint to us, we may collect information from you such as your name, email address, phone number(s) and address.

SENSITIVE INFORMATION

MND Beast Challenge does not generally collect information defined as 'sensitive information' in the Privacy Act (such as racial or ethnicity information, political associations, health information and criminal records).

WHAT DOES MND BEAST CHALLENGE DO WITH YOUR PERSONAL INFORMATION?

We will only use and disclose your personal information for the purposes which you provide it or a related secondary purpose which you would reasonably expect. This includes, for example:

- providing the products and/or services you have requested from MND Beast Challenge; and
- responding to any enquiries, feedback or complaints made by you; and
- assessing and administering any applications/registrations with MND Beast Challenge.
